Dec 23, 2019 Category:2019 albums Category:2018 albums On Thursday, after long held up by a federal judge in Texas, a US District Court unsealed several parts of the judge's opinion in a lawsuit against Planned Parenthood for allegedly profiting from fetal tissue. In a 41-page opinion, Judge Joe Fish ruled that Planned Parenthood affiliates could be sued for receiving reimbursement from the company that sells and harvests the tissue of aborted fetuses, and that the company in question was not protected by the Religious Freedom Restoration Act, or RFRA. The company is CMP of Houston. "Planned Parenthood and its affiliates and subsidiaries... conspired with each other and with others to illegally traffic in the dead bodies and the parts of the dead bodies of unborn children." —Judge Fish Further, Fish held that the pharmaceutical giant, Stryker, which is headquartered in Michigan, could be sued for allegedly allowing the sale of fetal tissue to be used for research. Fish's ruling directly affects CMP, the company of which he was a partner until early last year. "Planned Parenthood and its affiliates and subsidiaries... conspired with each other and with others to illegally traffic in the dead bodies and the parts of the dead bodies of unborn children," he wrote in his opinion. "They also conspired with each other and with Stryker to obtain aborted fetal remains that they knew were required for research, or were at least of a material nature." CMP, which also received a settlement from over \$270,000 from Planned Parenthood affiliates for violating a patient confidentiality agreement, has taken considerable umbrage at the ruling. "The decision correctly notes the no-fault nature of Planned Parenthood's business," CMP's general counsel, Leigh Goodman, said in a statement. "But the law requires that we can only be forced into accepting fetal remains and selling fetal parts if we receive compensation for the services that we provide to the women who carry their babies to term. That is the guiding principle of all our centers, facilities, affiliates and doctors. We will continue to do so." The Texas case was brought by the parents of a deceased unborn child. They say that they never consented to their child's fetal tissue being used for research. The parent's attorney said that the judge's
